
**Experience** :- Minimum 10 years of Experience in Public administration, law, academics, social work or management.

TA/DA at rates admissible to Class I Officers of the State Government will be provided.

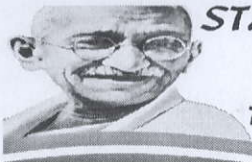
