

ANNUAL REPORT ON NATIONAL RURAL EMPLOYMENT GUARANTEE SCHEME: MEGHALAYA.

1. Notification of NREGA

The National Rural Employment Guarantee Act aims at enhancing the livelihood security of the people in rural areas by providing guaranteed wage employment through works that develop the livelihood resource base of that area so that in that process of employment generation durable assets are built up. The Act was enacted in September 2005. It was notified in 200 districts of 27 States on February 2, 2006. The Government has notified Meghalaya under NREGA on 1st April 2006 applicable for the two districts- West Garo Hills and South Garo Hills Districts due to Parliamentary Election for 2- Tura Constituency in February.

2. Key elements of the Act.

- Household domiciled in a village (not just those below the poverty line) are entitled to register for seeking employment.
- Job cards containing photographs should be issued to all entitled applications within 15 days of application.
- Demand for work from job card holders should be acknowledged and work allotted within 15 days.
- The instrument for allotting employment is unskilled manual work.
- Works taken up should be predominantly for water and soil conversation, afforestation and land development.
- 50% of the works should be implemented by Gram Panchayats.
- The shelf of projects for a village should be recommended by the Gram Sabha and approved by the Zilla Panchayat.
- Not contractors and machinery should be used.

60% wage component should be taken up.

- 3. Launching NREGA in the State.

The scheme was launched officially on 4th May 2006 in both the districts . Thereafter intensive campaign and preparatory works were started . As per section 4 of the Act, States are required to frame its own scheme and notify it for implementation .

State Scheme.

As Part IX of Constitution does not apply to Meghalaya, the Scheme has been framed in consistent with an Act by involving traditional tribal authorities. Some scheme highlights are:

i) At the village level, a Village Employment Council for NREGS (called VEC for short) consisting of male and female heads of each household constituted and invested with the responsibilities of Gram Sabha in so far as NREG Scheme is concerned. The meeting is chaired by a Village Headman/Traditional Village Head and a Secretary is elected from amongst the members.

ii). An Area Employment Council for NREGS (AEC for short) is constituted at the cluster level comprising of villages within a 2.5 km radius, and this Council consists of 3 (three) elected representatives from each Village Employment Council, one of them is a female and one will compulsorily be a Village Headmen/Traditional Village Head. The total number of Members of AEC should not exceed 20. A Chairman and a Secretary elected from amongst the members. The responsibilities of Gram Panchayat specified under the Act vested with the Area Employment Council.

iii) At the Block Level, the existing Block Selection Committee has been notified as Block Employment Council (BEC for short) to function as Intermediate Agency which will finalise and approve blockwise shelf of projects to be taken up under the programme, supervise and monitor the projects taken up at the block, and perform such other functions as may be assigned by DEC and State Council.

iv) At the District Level, the DRDA shall be the principal authority for planning and implementation of the Scheme. The Governing Body of DRDA has been notified as District Employment Council (DEC for short) which shall approve the District Employment Guarantee Scheme Plan, and supervise and monitor the projects taken up by AEC and BEC and perform such other functions as may be assigned by the State Council.

Clearance from the Ministry was received in July 2006 with certain suggestions for amendment in the State Scheme. Accordingly these amendments were incorporated in the Draft Scheme and notified on 28th July 2006. Prior to this, activities relating to publicity, awareness generation, capacity building and training was taken up at all levels. The registration of households, printing of job cards and all preparatory activities including photography of households were done .The Institutions formed in the two districts with the number of households registered under the scheme during 2006-07 is as follows:

Feed back from the field. 5.

Early trends from the field where the programme processes have Started to be institutionalized indicate the following features:

- i) New institutions have taken up the challenge with full enthusiasm , and there is the positive evidence of full cooperation by all sectors in the implementation of the scheme.
 - State has adopted a new system of institutions which have to be ii) in place prior to actual physical implementation of the NREGA works,. The delay in the implementation of the programme is to be appreciated as the State Scheme was notified only in July 28th 2006, and the Districts and Blocks have given tremendous effort despite technical constraints to start the work by November 2006. Formalising the AECs and VECs with the elected Chairpersons from among the Traditional Heads and Village Headmen was an enormous task.

- iv) The village-based annual shelf of works and five year Perspective plans has been prepared and local communities were facilitated by the District Administration through the Block and Technical Line Departments for professional support. The Annual Labour Budget and the shelf of projects were approved at different levels.
 - v) West Garo Hills District has taken good initiatives to introduce transparency in implementation and make information available in the public domain as well to bring in greater accountability in management. Convergence of Programmes by involving the new Peoples organization has positive impact specially in West Garo Hills District.
 - vi) Work time and motion studies to bring about greater transparency in the schedule of rural rates has been initiated by the DPC West Garo Hills District.
 - vii) Wage rate as per State Government notification under the Minimum Wages Act. There is an apprehension that there will be no demand for employment in certain pockets of the South Garo Hills District being the coal belt area where the wages is higher than the wage paid under the programme.
 - viii) Measurement of works for each muster roll was entrusted to Gram Sevaks as no sufficient technical staff was available. This is a very challenging task for Gram Sevaks.
 - ix) No extra cost is incurred for purchase of tools and implements
 - x) A rural connectivity was taken up in large number followed by water conservation works. In a hilly situation where habitation is scattered, rural connectivity is a top priority and many rural areas have been connected with motorable roads.
 - xi) Women participation is high. Community participation in the execution of works have seen no negative response.

6. Challenges and Steps taken to strengthen the Programme.

1. One of the challenges in the field have been the due to the fact that this has been the transition period from SGRY/NFFWP procedures, that are work-led and allocation based to NREGA procedures that are focused on employment, are demand-based and operate within a Legal framework.

2. The other is the absence of Panchayati Raj Institutions in the State, and the absence of a recognized system working at the grass root level for pro active partnership in the programme.

The State has initiated steps to address critical issues that have emerged in the course of programme implementation. These are as follows:-

6.1. Communication and awareness generation.

Communication is one of the critical areas for effective and efficient implementation of the NREGA. Intensive awareness campaign in all the rural areas about the rights and entitlements under the Act was carried out through Newspaper Advertisement, posters, and pamphlets in vernacular. In the second phase of communication campaign the focus is on details of State Scheme and key aspects of programme. This is being disseminated through easy to read booklet in vernacular,

Action has also been taken to deepen awareness of users through primers in relevant language, implementation manuals for Block, AEC and VEC officials, television and radio talks on critical elements of procedure manual.

6.2. Creation of Village Institutions:

This is a vital task for the District Programme Coordinator and Programme Officers to mobilize and create systematic approach for successful implementation of the programme. The State issued step by step instructions i) for formation of VECs / AECs and defining roles and responsibilities of Village, Block and District level Functionaries, and ii) for engaging community volunteers and Technical Assistants for strengthening village functionaries in their partnership with the State Government. Each VEC and AEC must sign social agreement with District Programme Coordinator giving commitment of villagers to actively participate implementation of NREGS with convergence approach. This approach has given a positive result specially in West Garo Hills in the implementation of flagship programmes of Government like Mid day meal, Sharva Shiksa Abhyan, Total Literacy Campaign and National Rural Health Mission, Total Sanitation Campaign.

6.3. Strengthening capacity building at the Block and AEC level.

In addition to the Special Campaign varied out by the Districts States have been asked by MORD to prepare training plans and undertake training of PRI functionaries, officials and Village Monitoring Committee members. Training is to be a continuous process. Centre has also provided Rs 8.70 lakhs to State Institute of Rural Development for taking up training and capacity programme. In the process, the main stakeholder to carry out the task alongwith SIRD is the Extension Training Centre which untiringly extended support for building capacity of Official and Non Official Rural Development Functionaries.

6.4. Partnership with NGOs:

The NGOs are engaged in training and capacity building of AECs and VECs through signing of MOU to strengthen implementation of NREGS: The NGOs are allotted specific VECs and AECs within the Blocks of the Districts to supervise NREGS works. They are paid remuneration as may be prescribed by the DPC concerned for each training conducted. There are 13 NGOs in West Garo Hills and six NGOs in South Garo Hills engaged for the purpose. The list is at Annexure III.

6.5. Strengthening Resource Support to States by GOI:

All reports/studies underscore the need to strengthen management at the block and Gram Panchayat(GP) levels through additional staffing. The Ministry of Rural Development raised the present 2% limit on administrative expenses to 4% to enable states to recruit adequate staff. Deployment of additional staff will enable States to discharge a number of responsibilities on time, such as issue of job cards, work sanction, measurement and payment. The enhanced limit will also enable States to invest more on communication, training and monitoring. However, the area of concern remains towards maintenance cost of AECs which are performing the task of Gram Panchayat.

6.4 **Regular monitoring and review**

The programme is being monitored by Ministry of Rural Development and also by the State Government at regular interval. The States have been instructed to undertake 2% inspection and verification at the Block, District and Gram Panchayat levels while the District will undertake 10% and Block 100%. The Centre is monitoring the programme by deputing National Level Monitors to each District.

6.5. Building Network with Line Departments and maintenance of Durable Assets.

To ensure quality of constructions and maintenance of assets, the instruction was issued from Chief Secretary to provide technical assistance in the preparation of plan and estimates for the projects identified . Nodal Officers were accordingly notified to closely coordinate and share technical expertise in the successful implementation of the programme.

Perspective plans prepared by experts in close consultation with communities and Village Local Bodies under NFFWP/NREGA.

7. Ensuring Transparency.

7.1 Institutional arrangement for transparency –

- a) At the village level, States have been asked to setup local Vigilance and Monitoring Committees and members of the Committee are being trained to be able to keep a watch on the quality of NREGA processes.
- b) At the district level, the District Vigilance and Monitoring Committee has been authorized to review NREGA. The Committee sat on 16.2.2007 at Tura for West Garo Hills District

- c) At the State level, State Employment Guarantee Councils have been setup to review and monitor the programme. It was notified on 4.9.2006.
- d) At the National level, the central Employment Guarantee Council rules have been notified on 25.05.2006. The Central Employment Guarantee Council has been constituted on 22.09.2006 and has met and reviewed the NREGA in detail.

All the documents on NREGA are also to be made available for public scrutiny.

7.2. Social Audit.

Social Audit exercise by the districts are being facilitated through training and resource materials. For this purpose the expert NGOs have been engaged. Social audit has been initiated by both the districts. The West Garo Hills have started Social Audit with effect from 10th March to 28th April 2007 in all the Blocks for the works that were taken up during 2006-07. Rs 250/- each AEC was given by the DPC for erecting Information Wall.

7.3. Muster Roll verification exercise.

States have been asked to undertake a Muster Roll verification exercise for 100% verification of all muster rolls on all NREGA works. Formats and guidelines have been received and action is being taken by the districts.

7.4. Management of Information System

A Computer based MIS has been developed to monitor the Programme (<u>http://nrega.nic.in</u>). This makes data transparent and

available in public domain to be equality accessed by all. However, operationalization of MIS, depends on the existing infrastructure available at the Blocks and the Districts. No online monitoring has been able to take place due to certain technical problems.


8. Streamlining financial system.

A State Employment Guarantee Funds is being setup as a non-lapsable Public Account to facilitate prompt transfer of funds to the Districts and Blocks . Fund rules have been framed and awaiting final concurrence of Finance Department. Format and guidelines for preparing a labour budget have been developed by Central and the same is being followed by the State and the Districts.

9. Setting-up effective grievance redressal mechanism.

The Districts have been asked to take action on complaints received. Any grievances that are being received are disposed off by the District Programme Coordinator from NREG Cell. No major complaint has so far been received by the State Government that require attention.
