

Preface

The Year 2013-14 was a big challenge for the MGNREGA in the State. To begin with, the approved Labour Budget was only **146.01 lakh** persondays. This indicated a lesser fund flow from the Central Government. However, in the implementation the State could achieve **190.28 lakh** persondays which was **30.32%** higher than the projection of the Central Government. Therefore, there was inadequate fund to meet the wage & materials that had accrued during the year leading to spillover of the pending liability to the next financial year. A total amount of **Rs. 328.77 crore** was spent during the year and **Rs. 75.15 crore** was spent on the liabilities of FY 2012-13.

The assets that have been created through MGNREGA have been very useful to the community. Several assets have received a lot of appreciation from Central Government Officials that have visited the State on numerous occasions. Efforts are being put in to encourage people to widen their selection of works from the new type of projects that can be undertaken through MGNREGA.

The State Corpus Fund was effectively utilized and an amount of *Rs. 35.00 crore* could be pooled as a temporary assistance apart from revolving *Rs. 11.1906 crore* that was borrowed during FY 2012-13. Women participation at **47.22%**, indicates a healthy trend of supporting rural household incomes through female members.

The complaint received at the State level have drastically reduced primarily due to focused approach, swift redress of grievances and stern action being taken against the culprits. To curtail the delay in the wage and material payments, the funds were channelized directly to the Blocks except for administrative expenses which were sent to the District. With time people have become more aware about the effectiveness and objective of the Social Audit. The petty issue could be resolved during the Public hearings.

An intensive effort has been taken to randomly select the projects implemented across the state for monitoring their adherence to the Act and ensure quality implementation. If improper execution are detected the concerned officials are given specific time frame to ensure effective redress of the issues.

Capacity Building has been a prime area of focus for the State Government. A total no. of **543** VEC functionaries were provided with 3 days training on record maintenance under MGNREGA. As VEC Functionaries keep in changing from time to time, due to several factors, capacity building is always a continuous exercise.

The Management of Information System (MIS) has been a boom in the implementation of the MGNREGA. The scale and magnitude of such a programme demands the interaction of modern age technology and systems. The blocks have continuously ensured sustained efforts in feeding data collected from the village level. Such information is utilised to monitor the progress and the mandate of the Act. Considering the challenge and dedication that needed to be put behind the MIS, awards have instituted to encourage performing Blocks and Districts. Online reporting has been started in 10 Blocks, in order to ensure better and faster update of reports. The VSATs have been installed.

At the end of Financial Year 2013-14, there was an unpaid liability of *Rs.* 148.76 *crore*. This would put a burden on the next financial. With better fund flow, there is a hope in improving the performance in the coming months.

The Mahatma Gandhi National Rural Employment Guarantee Act

Introduction

The Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) is a flagship programme of the Government of India that directly affects the lives of the rural people. The primary objective of the Scheme is to provide livelihood security to the households in rural areas of the notified districts by providing 100 (one hundred) days of guaranteed wage employment in a financial year to every household whose adult members volunteer to do unskilled work through creation of durable assets and to strengthen the livelihood resource base of rural people. The emphasis of the MGNREGA for providing livelihood opportunities through creation of sustainable assets at the village level has brought about transformation to the rural areas of Meghalaya.

The institutions viz. Village Employment Councils (VECs), have spearheaded the transformation in the village through community bonding, voluntary dedication and grass root mobilisation. Proper planning and selection of works are extremely important to ensure effective implementation of the programme and utility of the assets. The MGNREGA has empowered the grassroot institutions including the traditional institutions in the State. The formation of the VECs has uniquely blended the roles and responsibilities of the traditional institutions and those of the Panchayati Raj institutions, without disturbing the existing democratic setup. The voluntary engagement of functionaries, whose relentless efforts have ensured that the programme is successfully run, is the driving force behind the achievements being seen in the villages of the State. Apart from improving rural infrastructure, livelihood opportunities have given additional resources to the people, especially for women.

During FY 2013-14, of the projected employment demand of **146.01** *lakh* persondays as per the Approved Labour Budget, the state could surpass the projection and achieve **190.28** *lakh* persondays with an average of **52.27** Persondays per Household. The women participation rate is **47.22%** which is higher than the mandated level of **33%**.


In 2013-14, **3.64 lakh** households were provided employment and **99.17 %** of the funds have been utilised. Amongst the Job Card holders, **91.75%** belong to Schedule Tribe, **0.83%** belong to Scheduled Caste and **7.42%** are from 'Others'.


1. Works:

During FY 2013-14 an amount of **Rs. 35.00 crore** could be resolved through the State Corpus Fund.

Training & Capacity Building

MGNREGA has set a landmark by placing the community as a principal implementing agency to implement the scheme. The Act mandated planning and implementation from the Village level. The community is given the responsibility to plan, implement and execute works for their own development. MGNREGA, with its complex and multiprocesses involved, with rights and entitlements to be safeguarded and time bound to be met. It is necessary that training is a continuous affair, and not a one -time activity. And training of different stakeholders plays a very important role in deciding the success of any scheme. It is, therefore, imperative to generate awareness about the scheme; provide time to time training, to different stakeholders on different aspect of the scheme to meet the aim and objectives of the scheme. The need to fully make the VECs and Block level staffs aware of the operational guidelines, procedures for implementation, execution of works, monitoring and evaluation of works, and in data management is necessary for smooth implementation of the scheme.

Grievance Redress

During the FY 2013-14, the State Rural Employment Society (SRES) agressively continued to redress grievances received from various beneficiaries, NGOs, individuals, etc. pertaining to the implementation of the Scheme. As done in previous years, news reports have also been attended to and immediate inquiries have also been conducted whenever required. It is worth mentioning that there was a drastic drop in the number of complaints and negative news report during the Financial year. This can be attributed to the prompt redress actions and better capacity building carried out intensively across the state. During the FY, one inquiry was conducted by the SRES:

Seek explanation from the Block officials on the absence of beneficiaries' signature in MR but endorsed by the Gram Sevak.

Quality Monitoring

The MGNREGA has created a sustainable and durable assets in strengthening the livelihood resource base of the rural people. During the Financial year 2013-14, the State Rural Employment society (SRES) has engaged officials for monitoring and inspection of the various projects taken up by the VECs under the MGNREGA flagship.

Moreover, they also provide an opportunity to the State Government to promote awareness and clarify issues in the implementation of the programme.



MIS Reporting:

There is 100% MIS reporting by all the online Blocks. For the offline Blocks, due to software related constraints, the data is not 100% reflected whenever the website is updated. Now with only 2 (two) Blocks in offline mode, the errors in reflection of data is minimal compared to the previous year.

MIS Award:

The Screening Committee for MIS award under MGNREGA for FY 2013-14 constituted for the nomination of MIS Awards has submitted its recommendations. As per the recommendations of the Screening Committee, the MIS award is being given to one best performing district and three best performing Blocks. 






